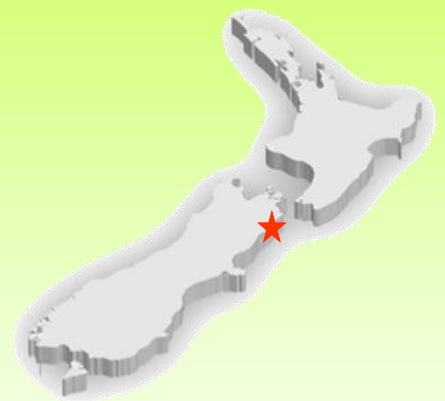

Justin leads Dot Loves Data's commercial operations and has more than two decades' experience providing strategic, policy and governance reporting and advice to the private, public and local government sectors.

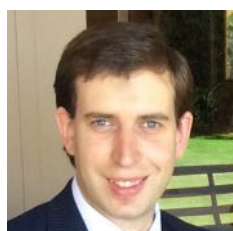
Justin served as Mayor and Deputy Mayor of Wellington.
